- Our Mid-Winter Conference was awesome! Thank you to all who attended. I would like to give a big thank you to Nate Suekel and Cynthia Jones for being the Mid-Winter Chairpersons and Melissa Suekel Homecoming Chairman. Also, I would like to thank Robert Holmes for doing the shopping for the hospitality suite and the other miscellaneous preparations for and during the conference. I would also give a huge thank you to Susan Thompson for all the hard work completing all necessary materials and the adjustments for the Conference.
- 2. US Army owned rifles assigned for Ceremonial use. If you have ceremonial rifles assigned to your Post and are past due on inventory please contact your District Commander and Senior Vice Commander Bob Tettleton to complete the required inventory. If your Post has ceremonial Rifles it would be a good time to do an inventory now. Inventories are required every three years to be sent to US Army Tank-Automotive and Armaments Command. Please make sure your Post does not become delinquent. These Rifles are US Government property and not Post, District or Department equipment. The organization is required to report the loss of any weapon to local authorities and to US Army Tank-Automotive and Armaments Command within twenty-four hours of discovery.
- 3. **Congratulations** to Voice of Democracy 1st place winner **Jaylee Ball**, sponsored by Mud Lake Post 8893 and Patriot's Pen 1st place winner **Brindle K. Beckner**, sponsored by Potlatch Post 10300.

The Parade of Winners will be held via Zoom this year due to COVID-19 precautions.

- 3. **Many of you have already received a letter** from American Life Income with my name signed at the bottom of the letter. The letter is legitimate. If you are interested, fill out the Response Card and mail it. An American Life Income Representative will contact you for an appointment. The Representative will contact you and, due to COVID precautions, usually make an appointment by Zoom or on the phone. They will mail you the certificate after you listen to their insurance offer. I did not find them to be pushy and if you do, let me know.
- 4. **I would like to thank Junior Vice Commander K.J. Babcock** for being the Master of Ceremonies at the VOD/PP Banquet. A big thank you for **VOD/PP/TOY/Safety Chairman Joe Riener** for all the work he put in to make these programs a tremendous success. I wish to thank **Chief of Staff/National Council Representative Rockey Davis** being the MC for the Homecoming.
- The 2022 Idaho State Convention, hosted by Lewiston's Sourdough Post 10043, will be held in Lewiston, ID, June 9 12, 2022, at the Hells Canyon Grand Hotel (Formerly the Red Lion Hotel) in Lewiston. Convention information will be in the March/April General Orders.

6. **Membership:** As of 30 January 2022, Idaho has 7 Posts that are 100% or greater in membership and 4 Districts are at 90% or above. No District is at 100%. The Department is 630 members away from reaching 100% and stands 33rd out of 52 Departments at 90.40%. We need an average of 5 members per day (including Saturday and Sunday) to reach 100% by June 15th. Of course, the more we process per day, the faster we achieve our goal. **Contact your Area Recruiter/Trainer, or Department Membership Chairman Lucky Gallego for assistance.**

We are 214 members "BEHIND" where we were this time last year. Call the members that have not renewed their membership and <u>urge them to renew NOW</u>. District 2 is leading the Department in membership.

Post Commanders, Quartermasters and Adjutants need to get on the phone and get the calls made NOW and do not wait until May.

- 7. **Department Safety Program**. The Department Safety program website has been updated with our 2021-2022 first responder winners.
- 8. **The 2022 Department Raffle has begun.** Thanks to people purchasing unsold Department Raffle tickets at the Mid-Winter Conference in January the Department sold all of the 6,000 tickets supporting the VFW Department of Idaho Voice of Democracy and Patriots Pen Program. While there is an incentive if the Post and District that sell their allotted tickets, the purpose to support our students participating in the programs not a fund raiser for the posts and districts. - 9. **Posts should begin considering** who will be nominated for <u>Comrade of the Year</u> and for the <u>Lifetime Achievement Award</u>. Winners will be selected at the Convention in June of 2022 in Lewiston. It is not too early to start developing nominations for these awards.
- 10. **Nominations for Post Officers will be in March with Elections to be held in April**. Post Commanders must ensure that all elected positions are filled. Please ask your members to consider a nomination or appointment for those individuals that would like to help your post to grow and make it strong supporter of Veterans in your community.
- 11. Displaying Military Service Symbols. Military service flags, insignias, etc., should be displayed in the following order (left to right as you face the flags): Army, Marine Corps, Navy, Air Force, Space Force and then Coast Guard.
- 12. All American Dashboard. Military Assistance Program grants have been launched to show Departments and Posts how much in grant assistance that has been received from National HQs to supplement the Unmet Needs financial grants and VFW Sport Clips Help-A-Hero scholarship statistics. The information charts reside on the KPI tools section. Please read the 2021-22 Membership program for more details. Posts need to sign up five new Action Corps subscribers, create a Facebook page, two separate partnering events along with a 10% increase in Community Service Impact from last year. They must submit reports through the dashboard to gain credit.
- 13. **The All State Matrix**. It is imperative that each Post complete their VOD/PP entries on the All American dashboard, if you have not done so when you read this, do it now. This way the Department can verify the Post has met their eligibility for the VOD/PP programs for All State. If you want to see the All State Matrix please check the Department website at vfwidaho.org.

14. **From the National Commander-in-Chief.** Starting 01 Jan 2022 every VFW Post that signs up and submits full membership dues for each member will receive a grant based on the type of membership submitted, while funds last. Full membership dues include the per capita for National, Department and the Post. New to the VFW Life member or reinstate annual to life with full life member payment, \$30.00 rebate. New to the VFW Life member or reinstate annual to life member installment payment, \$20.00 Rebate. New to the VFW annual member, \$20.00 Rebate. Reinstate Annual member, \$10.00 Rebate

Minutes:

Committee Reports:

Budget Review

New Business

- A. National Representative PSC Davis spoke regarding the following:
 - 1. He reiterated the need to check the "Scrub List" for names listed as deceased in error.
 - 2. CET: National is allowing only one Teacher of the Year from each Department this year. This is creating a "hew and cry" from Departments who feel that the three per department is a more balanced way to judge and award teachers. It is unfair for a kindergarten teacher to need to compete against a high school teacher. Therefore,

- the National Council of Administration is going to discuss this at their next meeting. PSC Davis requested a consensus that Idaho concurs with returning to 3 winners and he will take that to the next meeting. Members of the COA agreed.
- 3. There has been little advertising of the VFW by the National Organization and the NCOA will also be discussing this topic.
- B. District 5 Commander Troy Junior asked if Idaho could sponsor a house at the National Home for Children. Discussion revealed that this is an expensive and ongoing commitment that the Department of Idaho cannot afford at this time. It is something to look into in the future.

Remarks by Senior Staff

- A. Senior Vice Commander Bobby Tettleton emphasized that the Posts/members need to work membership and especially recruitment and retention of younger veterans.
- B. Junior Vice Commander KJ Babcock stated that activities should be more visible in our communities. Recruitment can be done at the same time in some of the activities. Also, Posts need to use the online tools to record activities often and very descriptively.

Quartermaster Holmes reported that \$927.25 has been collected and will be sent to National for tornado relief.

MINUTES OF GENERAL SESSION MIDWINTER CONFERENCE January 8, 2022

The General Session of the Department of Idaho Veterans of Foreign Wars was opened in ritual form by Commander Douglas E. Welch at 10:30 a.m. on January 8, 2022, at The Riverside Hotel in Boise, Idaho, following Joint Opening ceremonies.

Roll Call was taken and all Council of Administration members were present except PSC Bill Heyob, Surgeon Dareld Hazeltine, District 4 Commander Owen Spurling, and District 7 Commander Richard Hollingsworth. All were excused.

New Business

- A. National Representative PSC Rockey Davis addressed the issue of just one Teacher of the Year per Department. The NCOA will discuss returning to 3 levels awarded at Departments and sent to National. District 2 Commander Joe Riener moved to support reinstating Teacher of the Year to three levels. However, only one is needed from a Post to qualify for All State or All American consideration. PSC Davis clarified that the number of Teachers of the Year to qualify for All American is at the discretion of the incoming Commander-in-Chief; the number o qualify for All State is at the discretion of the incoming Department Commander. Judge Advocate Gordon Petrie seconded. Motion passed to support returning to 3 levels of competition.
- B. VFW Advertising: Comments included a) move the advertising to social media as that is much larger today; b) Posts, Departments and National need to do more and be more proactive; c) check out free advertising as with community service announcements.
- C. Changing Posts from C-4 to C-19 status. Discussion of this yielded that every post in the department must do it at the same time, b) the change can only be done in December, c) it would cost \$500.00 per Post, d) each Post needs to be canvassed to see if that is feasible in December 2022. Discussion led to the District Commanders doing the canvassing and reporting to QM Holms for action. Jim Mariman (Post 63) moved to have the Department Quartermaster survey all Posts to determine the number wanting and able to fund the change.
