Subject: Community Activity Reporting

Comrades,

We are in the first month of the new VFW year and I want to encourage every Post to take an active role in supporting their community and to get appropriate credit by utilizing the online reporting system.

Here are some basic guidelines that will make your reporting accurate and effective.

- 1. How to report Log on to the VFW Department of Idaho website under Members Only. On the homepage, click on Program Reporting, complete the report and click submit. It's that easy!
- 2. When to report The vision from National is a member logs in on their cellphone, tablet, laptop, or PC **AT THE TIME OF THE ACTIVITY**. Yes, any member may submit a community activity and they don't need to wait until the end of the month, and it doesn't have to be just one post member making the submission.
- 3. What to report This can get tricky, please review the list of what to and what not to report in the Standard Operating Procedures (SOP) on the Department website. However, here's a simple set of guidelines.
 - a. Is the activity representing the VFW?
 - b. Is the activity beneficial to the community?
 - c. Are the member(s) volunteering their time and/or donation?

When describing your activity, include those three points. For example, "5 Post members volunteered to clean up the park and represented themselves as members of the VFW."

4. Don't abbreviate or use acronyms. When I was in the Air Force, I actually wrote this sentence, "Call TACC to coordinate for AR 8/BA at FL270 ARCT 1300Z with 48K off." I don't expect you to understand that, and please don't expect me or VFW National to understand your acronyms and abbreviations. SPELL IT OUT.

8. 'A Genuine Hero': The last living WWII Medal of Honor recipient has died Paul Livengood, KTVB, June 29, 2022



ARLINGTON, Texas — America's last living World War II Medal of Honor recipient has passed away.

Hershel "Woody" Williams, 98, died early Wednesday morning in West Virginia, according to a press release from the National Medal of Honor Museum, which is being built in Arlington.

Williams enlisted into the Marine Corps Reserve in Charleston, W.Va., in 1943

and was trained to use a flamethrower. He received the Medal of Honor for actions above and beyond the call of duty during the Battle of Iwo Jima, when he "repeatedly exposed himself to fire over several hours while singlehandedly destroying enemy pillboxes with his flamethrower to clear the way for American tanks and infantry."

The President and CEO of the National Medal of Honor Museum Foundation, Chris Cassidy, released this statement regarding Williams' death:

"Our nation has lost a genuine hero with the passing of Medal of Honor recipient Woody Williams. An American treasure and an extraordinary man both on and off the fields of battle, he left an enduring legacy of service to his country with his many initiatives on behalf of veterans and Gold Star families. We were blessed to have had him join us for the National Medal of Honor Museum groundbreaking ceremony on March 25th - his final Medal of Honor Day. His enduring legacy of selfless service will continue to inspire generations to come as it is experienced by all who visit the Museum. We join his family, friends, and all Americans in

mourning this exceptional loss. As a recipient of our country's highest honor and a member of the greatest generation, Woody was truly one of the greatest of the greats!"

President Truman presented Hershel "Woody" Williams with the Congressional Medal of Honor on October 5, 1945.

In order to recognize and serve Gold Star families (spouses, children, parents, siblings or others whose loved one died in service to our nation), Williams created the Woody Williams Foundation, a nonprofit which works to establish permanent Gold Star Families Memorial Monuments in communities across the United States.

In June of 2021, Williams attended his grandson's Marine boot camp graduation in South Carolina. Later that same year, in November, the AutoZone Liberty Bowl honored Williams and over 250 Gold Star Family members from across the country.

Williams advanced to the rank of Chief Warrant Officer during his career as a Marine and honorarily retired from the Corps in 1969.

VOD, Patriot's Pen & Teacher of the year Brochures should be ready to go to the schools by the end of August.
Membership for the New Year began on 1 July. By Nov 11 posts should be at 85%, Mid-Winter Conference 95%. Work the continuous and unpaid members. Recruit new members and see if you can sign all as life members.
District Commanders set up inspection schedules so as to have them complete by 31 December.
Bonds will expire on August 31 st . New Bonds are due to Department HQ in August.
